INSTRUCTIONS TO THE CANDIDATES FOR PARTICIPATION IN  
COUNSELLING PROCESS AND SEAT SELECTION**

Sri Devaraj Urs Academy of Higher Education and Research is holding a single window counselling for admission to the Post -Graduate Medical courses at Sri Devaraj Urs Medical College, Kolar for the academic year 2010-11 to ensure a merit based admission. For this purpose, The Academy has already conducted entrance examination SDUAHER-AIPGMET-2010 for the determination of merit.

The Rank List and the Rank Cards of SDUAHER-AIPGMET-2010 have been generated and dispatched already. General Merit Candidates (Karnataka/ Non Karnataka), who have secured 50% and above in SDUAHER-AIPGMET-2010 are eligible for Counselling and seat selection. However, for candidates belonging to SC, ST and OBC, 40% is the minimum marks **for eligibility** to participate in the Counselling and seat selection.

1. SDUAHER-AIPGMET-2010 Rank Card
2. SSLC or 10th Standard or equivalent Marks Card
3. MBBS (All Marks Cards)
4. Attempt/s Certificate

5. Internship completion Certificate / Certificate for the expected date of completion of internship in case of candidates who have not yet completed their internship at the time of Counselling.
6. Provisional / Permanent degree certificate.
7. State / Central Council registration certificate - Permanent / Provisional .
8. Certificate of recognition status of MBBS qualification by MCI issued by the Head of Institution.
9. Candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST) and Other Backward Classes (OBC) are eligible to claim the lower eligibility (40%), provided they furnish a caste certificate issued by relevant authority not less than Tahasildar of the Taluk.
10. Demand Draft to be drawn in favour of '**The Registrar, SDUAHER, Kolar**' payable at Kolar for the annual tuition fee and other fees specified (Details refer to [www.sduu.ac.in](http://www.sduu.ac.in))
11. The excess amount if any, paid by the candidate for the course selected will be refunded, subject to realization of D.D. amount.

**THE FOLLOWING CERTIFICATES ARE REQUIRED TO BE SUBMITTED AT THE COLLEGE DURING THE TIME OF ADMISSION:**

1. Eligibility certificate issued by The Academy (SDUAHER)
2. Transfer Certificate
3. Migration Certificate

**1. Eligibility**

As per the Post Graduate Regulation 2000 of Medical Council of India, the minimum percentage of marks in the entrance test (SDUAHER-AIPGMET-2010) for eligibility for admission to Post Graduate Courses shall be 50% for general category candidates and 40% for the candidates belonging to Scheduled Castes, Scheduled Tribes and Other Backward Classes.

**Note: Only those candidates who have completed / expected to complete their Internship on or before 30<sup>th</sup> April, 2010 are eligible for counseling and seat selection.**

  2. The candidate can select these seats at his/her own risk
  3. The candidate selecting the seat from this category need not pay the annual tuition fee and other fees at the time of seat selection
  4. Fee should be paid on approval of seats by Government of India

### 3. TUITION FEE AND OTHER FEES

The Annual tuition fee and other fees for the first year course should be paid by the candidates, in the form of a **Demand Draft (DD) drawn in favour of The Registrar, SDUAHER, Kolar, payable at Kolar**. The candidates should be ready with the Demand Draft to participate in the counselling process for seat selection. Failing which, they will not be allowed to participate or enter the Counselling hall. **Cash or cheque, will not be accepted for any reason.**

#### Note :

- Annual tuition fee and other fees are payable on or before 15th May every subsequent year. Failure to pay entails suspension from the course of study.
- **Each student of The Academy will be provided with a free laptop.**

### 4. COUNSELLING AND SEAT SELECTION PROCESS BY THE CANDIDATE

The entire process of counselling and seat selection in The Academy is controlled by a computer system right from the stage of registration of the candidate to the stage of printing of Allotment letter. The highly sophisticated software used in the process can control the registration, provide data for verification of the original documents, biometric verification and to take care of the selection of the seats by the candidates in the order of merit, payment of fees and printing of Allotment letter. A candidate who has the better rank gets the opportunity to select a seat, a candidate who has the rank next to him cannot think of bypassing him. He/She will have to wait for his turn at the seat selection terminal. A dynamic screen will show availability of seats. The moment a seat is selected by the candidate, the computer will show one seat less against the total number of seats.

## **Counselling and seat selection process :**

### **a. Verification of the Original documents & Demand Draft.**

Each candidate should get all original certificates and Demand draft verified at the verification counter and obtain the verification form duly signed by the authorized signatories.

### **b. Biometric verification of the candidate**

Biometric, photo and signature verifications will be made at the registration counter. Therefore, the candidate is required to be present compulsorily for seat selection. Only one person ( Parent / Guardian or Spouse ) can accompany the candidate for the entire counseling and seat selection process.

### **c. Registration of the candidate**

1. On the day of counselling (06.03.2010) the registration of the eligible candidates will take place from 9.00 AM to 1.00 PM.
2. All eligible candidates should get themselves registered within this time period.
3. No candidate shall be permitted to get registered once the process of registration is declared as completed.
4. The registration is mandatory. Failing to attend the registration process will disqualify the candidate from this counselling (First) as well as subsequent Counselling process for seat selection.

### **d. Selection of seat**

1. The counselling for seat selection will commence on 06<sup>th</sup> March 2010 from 2.00PM onwards.
2. The registered candidate will be allowed to participate in the seat selection in accordance with the notified time schedule and as per the order of merit. If the candidate is not present when called in the order of merit, he/she shall forfeit the right to select any seat and will be disqualified from the seat selection process.
3. After verification of original certificates, The Academy will retain only one set of photocopies and the original set of Certificates/documents will be returned to the candidate for submitting the same to Sri Devaraj Urs Medical College at the time of admission as mentioned in the allotment letter.
4. The candidate who has selected a seat will be given a **letter of offer** for payment of tuition fee and other fees for the course of study.

5. The candidates who have selected seats in the first round of Counselling shall get themselves admitted in the Sri Devaraj Urs Medical College on or before 22<sup>nd</sup> March, 2010, 5.00 PM, failing which the seat allotted shall be forfeited. The following documents as applicable, shall have to be submitted directly to the college at the time of admission.

(i) Eligibility certificate issued by The Academy (SDUAHER)

(ii) Transfer Certificate

(iii) Migration Certificate

**e. Remittance of tuition fee and other fees :**

The Annual tuition fee and other fees for the first year of course should be paid by the candidates after receiving the letter of offer , in the form of a **Demand Draft (DD) drawn in favour of The Registrar, SDUAHER, Kolar, payable at Kolar at the counter for remittance of fees. Cash or cheque will not be accepted for any reason.**

**f. Issue of Allotment letter**

After remittance of the tuition fee and other fees at the specified counter in the counselling hall, the candidate will be given the allotment letter that he/she should produce at the college to get admitted for the course of study.

**Note :**

**He/she should get admitted to the college (SDUMC) on or before 22<sup>nd</sup> March 2010, 5.00 PM as mentioned in the allotment letter. Failing which, the seat allotted will be forfeited.**

**5. GROUNDS FOR REJECTION:**

- If on verification, the documents of the candidates are not found to be in order or if there is any falsification of documents or if the Advisory committee is not convinced about the documents submitted at the verification counter, his/her candidature will be rejected.
- If there is a mismatch of photo, finger impression, signature of the candidate or if there is a reasonable doubt by the Advisory Committee that there is malicious intent by the candidate to impersonate, such candidate/s will be debarred from counselling and seat selection process and criminal proceedings may be initiated.
- If the candidate fails to produce the prescribed tuition fee and other fees in the form of Demand Draft, his/her candidature will be rejected.
- Candidate must be physically present and any attempt for proxy registration will be rejected.

## **6. REFUND**

Those Candidates who have been allotted seats and have not taken admission in the college shall be given refund of fee after deduction of 5% (Five percent) from the total fee paid. This shall be applicable to only those candidates who surrender their seats and submit a written request for refund well in advance within the specified time and date mentioned in the allotment letter for getting admitted to Sri Devaraj Urs Medical College, Kolar.

**7. The issue of Allotment letter by Sri Devaraj Urs Academy of Higher Education & Research is provisional. It is to enable the candidate to join Sri Devaraj Urs Medical College, Kolar, subject to his meeting all the eligibility requirements as prescribed by MCI and Sri Devaraj Urs Academy of Higher Education and Research, Kolar, Karnataka.** Hence, all the original documents are once again verified at the college before admission. Besides biometric, photo and signature verifications would also be carried out.

## **8. LEGAL JURISDICTION**

Any dispute that may arise in respect of the counselling and seat selection process and admission to Sri Devaraj Urs Medical College, is subject to the jurisdiction of the Hon'ble High Court of Karnataka.

## **9. SECOND ROUND OF COUNSELLING**

The details of second round of counselling and seat selection process will be announced later.

## **10. ASSISTANCE**

Candidates seeking any clarification or assistance for specific problems with regard to the counselling and seat selection process are required to contact SDUAHER Office well in advance. SDUAHER suggests all the candidates to visit the website regularly for the latest updates.

On the day of counselling and seat selection process the candidates are required to approach the Advisory Committee for clarification or assistance.
