**INSTRUCTIONS TO THE CANDIDATES FOR PARTICIPATION IN  
COUNSELLING AND SEAT SELECTION PROCESS**

Sri Devaraj Urs Academy of Higher Education and Research is holding a single window counselling for selection of seat and subsequently, admission to the Under-Graduate Medical course (MBBS) at Sri Devaraj Urs Medical College, Kolar for the academic year 2010-11. To ensure a merit based seat allotment and admission process, The Academy has already conducted entrance examination SDUAHER-AIUGMET-2010 for the determination of merit.

The Rank List and the Rank Cards of SDUAHER-AIUGMET-2010 have been generated and dispatched already. General Merit Candidates (Karnataka/ Non Karnataka), who have secured marks of 50% and above have been declared eligible for counselling and seat selection process. Candidates belonging to SC, ST and OBC, who have submitted relevant documents and secured marks of 40% and above are included in the eligibility, list as per the notification and brochure details.

The Candidate should have passed the qualifying examination which is 2nd PUC or 10+2 higher secondary or equivalent examination. The last two years of study comprising Physics, Chemistry and Biology (PCB) with English as a compulsory subject, must have passed these subjects individually and must have obtained a minimum of 50% of marks taken together in Physics, Chemistry and Biology. In addition, in the competitive entrance test, the candidate must have secured not less than 50% marks in Physics, Chemistry and Biology.

In respect of candidates belonging to Schedule Caste, Schedule Tribes or other Backward Class the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination and competitive entrance examination be 40% instead of 50% as stated above.

Age: The candidates should have completed 17 years of age on or before 31st day of December of the year of admission.

1. SDUAHER-AIUGMET-2010 Rank Card.
2. SSLC or 10th Standard or equivalent Marks Card.
3. 2<sup>nd</sup> PUC or 12<sup>th</sup> Std or equivalent Marks Card.
4. Candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Classes (OBC) who are declared eligible under these categories should produce caste certificate issued by relevant authority not less than Tahasildar of the Taluk.
5. Demand Draft to be drawn in favour of **'The Registrar, SDUAHER, Kolar, payable at Kolar** for the annual tuition fee and other fees. ( For details refer fee structure)

**THE FOLLOWING ADDITIONAL CERTIFICATES ARE REQUIRED TO BE SUBMITTED AT THE COLLEGE DURING THE TIME OF ADMISSION:**

1. Eligibility certificate issued by The Academy (SDUAHER)
2. Transfer Certificate
3. Migration Certificate

## 1. Eligibility

As per the Under Graduate Regulation 2000 of Medical Council of India, the minimum percentage of marks in the entrance test (SDUAHER-AIUGMET-2010) for eligibility for admission to Under Graduate Course shall be 50% for general category candidates and 40% for the candidates belonging to Scheduled Castes, Scheduled Tribes and Other Backward Classes.

## 3. TUITION FEE AND OTHER FEES

The Annual tuition fee and other fees for the first year, M B B S course should be paid by the candidates, in the form of a **Demand Draft (DD) drawn in favour of The Registrar, SDUAHER, Kolar, payable at Kolar.** The candidates should have the Demand Draft ready to participate in the counselling and seat selection process. Failing which, they will not be allowed to participate or enter the Counselling hall. **Cash or cheque, will not be accepted for any reason.**

**Note :**

- Annual tuition fee and other fees are payable on or before 31<sup>st</sup> May every subsequent year. Failure to pay entails penal action including suspension from the course of study.
- Each student of the Academy will be provided with a free laptop.

## **SCHOLARSHIPS:**

The Academy awards 20 scholarships of Rs.25,000/- (Rupees Twenty five thousand only) per annum for undergraduate (MBBS) students.

- 10 of these scholarships are for students of General Merit category (GM), (named after Late Sri.Ramakrishna Hegde, former Chief Minister of Karnataka).
- 10 scholarships are for students under OBC category, (named after Sri Devaraj Urs, former Chief Minister of Karnataka).
- Besides these scholarships, The Academy also reduces the annual tuition fee by Rs.50,000/- (Rupees fifty thousand only) for undergraduate(MBBS) students belonging to OBC of Karnataka State (based on economic status) .

**Note: These scholarships and fee concession are awarded subject to approval of the Scholarship Committee of The Academy.** The list of the eligible candidates will be finalized only after the admission process for the academic year 2010-11 declared over.

## **4. COUNSELLING AND SEAT SELECTION PROCESS BY THE CANDIDATE**

The entire of counselling and seat selection process in The Academy is controlled by a software system right from the stage of registration of the candidate to the stage of printing of Allotment letter. The highly sophisticated software used in the process can control the registration, provide data for verification of the original documents, biometric verification and to take care of the selection of seats by the candidates in the order of merit, payment of fees and generation of Allotment letter. A candidate who has the better rank gets the opportunity to select a seat first and a candidate who has the rank next to him cannot bypass the better merited candidate. He will have to wait for his turn at the seat selection terminal. A dynamic screen will show availability of seats. The moment a seat is selected by the candidate, the computer will show one seat less against the total number of seats available.

### **a. Verification of the Original documents & Demand Draft.**

Each candidate should get all original certificates and Demand draft/s verified at the verification counter and obtain the verification form duly signed by the verification officers.

### **b. Biometric verification of the candidate**

Biometric, photo and signature verifications will be made at the registration counter. Therefore, the candidate is required to be present compulsorily. Candidate who has completed the biometric verification successfully will be allowed to take part in the counselling and seat selection process.

### **c. Registration of the candidates**

1. On the day of counselling (25.06.2010) the registration of the eligible candidates will take place from 9.00 AM to 1.00 PM.

2. All eligible candidates who have been declared eligible by The Academy should get themselves registered within this time period as mentioned above.
3. No candidate shall be permitted to get registered once the process of registration is completed.
4. The registration is mandatory in the First round of Counselling, failing to attend the registration process will disqualify the candidate from this counselling (First) as well as second and subsequent counselling and Seat selection process.

**d. Selection of seat and admission**

1. The counselling and seat selection process will commence on 25.06.2010 from 2.00PM onwards.
2. The registered candidate will be allowed to participate in the seat selection process in accordance with the notified time schedule and as per the order of merit. If the candidate is not present when called in the order of merit, candidate shall forfeit the right to select any seat and will be disqualified from the seat selection process.
3. After verification of original certificates, The Academy will retain only one set of photocopies and the original set of Certificates/documents will be returned to the candidate for submitting the same to Sri Devaraj Urs Medical College at the time of taking admission as mentioned in the allotment letter.
4. The candidate who has selected a seat will be given a **letter of offer** for payment of tuition fee and other fees for the course of study.
5. Candidate shall then proceed to the second counter for remittance of fee. After the payment of the fee, candidate shall proceed to the third counter for obtaining letter of seat allotment.
6. **The candidates who have selected seats in the first round of Counselling shall get themselves admitted in the Sri Devaraj Urs Medical College on or before 09.07.2010, 5.00 PM, failing which the seat allotted shall be forfeited. The following documents as applicable, will have to be submitted directly at the time of admission to the college.**
  - (i) Eligibility certificate issued by The Academy (SDUAHER),
  - (ii) Transfer Certificate.
  - (iii) Migration Certificate
7. **The candidate who has forfeited or surrendered the seat will not be permitted to attend the second and subsequent counselling and Seat selection process, if any.**

**e. Remittance of tuition fee and other fees :**

The Annual tuition fee and other fees for the first year of course (M B B S) should be paid by the candidate after receiving the letter of offer, in the form of a **Demand Draft (DD) drawn in favour**

**of The Registrar, SDUAHER, Kolar, payable at Kolar at the counter for remittance of fees. Cash or cheque, will not be accepted for any reason.**

**f. Issue of Allotment letter**

After remittance of the tuition fee and other fees at the specified counter in the counselling hall, the candidate will be given the allotment letter that he/she should produce at the college to get admitted for the course of study.

**Note:**

**Candidate should get admitted to the college (SDUMC) on or before 09.07.2010, 5.00 PM as mentioned in the allotment letter. Failing which, the seat allotted will be forfeited.**

**5. GROUNDS FOR REJECTION:**

- If on verification, the documents of the candidate are not found to be in order or if there is any, falsification of documents or if the Advisory Committee is not convinced about the documents submitted at the verification counter, his/her candidature will be rejected.
- If there is a mismatch of photo, finger impression, signature of the candidate or if there is a reasonable doubt by the Advisory Committee that there is malicious intent by the candidate to impersonate, such candidate/s will be debarred from counselling and seat selection process and criminal proceedings may be initiated.
- If the candidate fails to produce the prescribed tuition fee and other fees in the form of Demand Draft, his/her candidature will be rejected.
- Candidate must be physically present and any attempt for proxy registration will be rejected.

**6. REFUND**

Those Candidates who have been allotted seats and have not taken admission in the college shall be given refund of fee after deduction of 5% (Five percent) from the total fee paid. This shall be applicable to only those candidates who surrender their seats and submit a written request for refund stating reasons well in advance within the specified time and date mentioned in the allotment letter for getting admitted to Sri Devaraj Urs Medical College, Kolar.

**7. The issue of Allotment letter by the Sri Devaraj Urs Academy of Higher Education and Research, is provisional. It is to enable the candidate to join Sri Devaraj Urs Medical College, Kolar, subject to his meeting all the eligibility requirements as prescribed by MCI and Sri Devaraj Urs Academy of Higher Education and Research, Kolar, Karnataka.**

All the original documents are once again verified at the college before admission. Biometric, photo and signature verifications would also be carried out at the college.

## **8. LEGAL JURISDICTION**

Any dispute that may arise in respect of the counselling and seat selection process and admission to Sri Devaraj Urs Medical College, is subject to the jurisdiction of the Hon'ble High Court of Karnataka.
